Rental Agreement and Release and Acknowledgement of Risk

I, _____ as Lessee (Customer), understand and acknowledge that the activity to be engaged in through my rental of an inflatable, interactive amusement device (bounce unit), and/or any other item being rented (equipment), brings with it both known and unanticipated risk to myself, my guests, and to my invitees. Those risks include, but are not limited to, falling, slipping, crashing, colliding, and could result in injuries, illness, disease, emotional distress, death and/or property damage to myself, and/or guests and invitees. I voluntarily release, indemnify, hold harmless and discharge KNK Jumpers (The Company) from any and all liability, claims, demands, actions, or right of action whether personal to me or to a third party which are related to, arise out of, or are in any way connected with the rental of any KNK Jumpers bounce unit or equipment, including any and all liability, claims, demands, actions, or right of action allegedly attributable to negligent acts/omissions. I agree to reimburse any reasonable attorney's fees and costs which may be incurred by KNK Jumpers in defense of such liability, claim, demand, action, or right of action.

*All riders **must remove shoes, eye glasses, and any sharp objects from their person or clothing** before playing on, utilizing, or otherwise mounting any KNK Jumpers bounce unit.

*To avoid neck and back injuries, **flips, summersaults, or any other acrobatic maneuvers are strictly prohibited** while playing on, utilizing or otherwise mounting any KNK Jumpers bounce unit.

* As the Lessee of any KNK Jumpers equipment and/or bounce unit, children's safety **depends upon the Lessee**. The Lessee's **personal supervision is absolutely required**. The safety of all riders on a KNK Jumpers bounce unit is the **Lessee's responsibility**. INITIAL: _____

***FOR LESSEES RENTING THE SKY FALL BOUNCE UNIT:** The Lessee understands, warrants, and agrees that only riders aged 13 and above are permitted to play on, utilize, or otherwise mount the Sky Fall bounce unit. INITIAL: _____

*Any rented bounce unit and/or equipment is only to be used for its ordinary purpose(s).

Safe Operation Acknowledgment: Lessee acknowledges that he/she has been instructed about and fully understands the safe operation of the KNK Jumpers bounce unit and/or equipment that is the subject of this Rental Agreement. Lessee agrees to observe all safety precautions. Lessee also represents and warrants the safe return of the item(s) rented.

Maintenance: Lessee represents, warrants, and agrees to return the rented KNK Jumpers bounce unit and/or equipment in the same condition as when received, ordinary wear accepted.

Title: Lessee agrees to maintain the rented KNK Jumpers bounce unit and/or equipment in his/her custody and not to sublease, rent, sell, remove from the Delivery Address, or otherwise transfer such KNK Jumper bounce unit and/or equipment to any entity who is not a party to this Rental Agreement. The KNK Jumper bounce unit and/or equipment shall remain the property of the Lessee until which time KNK Jumpers removes said item(s), from the Delivery Address, after the Lessee's scheduled event on the designated rental date.

Inclement Weather: If it rains, snows, sleets, hails, is thundering or lightening, and/or winds are strong before your scheduled event, KNK Jumpers reserves the right to cancel delivery. If inclement weather develops before or during your scheduled event, KNK Jumpers reserves the right to retrieve the rented bounce unit and/or equipment to avoid damage; however, no refund will be given. Unused credits may be applied to a future scheduled delivery.

Valid I.D. of the Lessee must be presented and verified and payment made at the time of delivery. **Checks are not accepted.**
